



Nebo School District Chromebook Protection Plan & Usage Agreement

Dear Parent/Guardian

Nebo School District is providing and administering a Nebo Chromebook Protection Plan (NCPP) for students and parents as part of our 1:1 Chromebook program. Enrollment in NCPP is optional with the understanding that parents/students carry the full liability if no protection plan is selected. Additionally, parents may also opt to use a third-party protection.

NCPP covers “accidental damage” to the device and is designed to limit a family’s financial responsibilities for any damages as described in the protection plan section below.

Plan Fee/Coverage

- ❖ **NON-REFUNDABLE FEE:** \$30 (not pro-ratable) for the current school year
- ❖ **LIMIT LIABILITY:** \$300
- ❖ **COVERAGE:** Repair/Replacement of school issued Chromebook and charger (one-time replacement)

Effective Coverage/Expiration Dates

- ❖ **EFFECTIVE DATE:** Based on the receipt of payment.
- ❖ **EXPIRATION DATE:** Last day of applicable school year. (May be extended with a Summer Rental Agreement).

Coverage

- ❖ **ACCIDENTAL DAMAGE:** Pays for accidental damage caused by liquid spills, drops, or any other unintentional event.
- ❖ **THEFT:** Pays for loss due to theft; the claim requires a police report to be filed.
- ❖ **FIRE:** Pays for damage of the Chromebook due to fire; the claim must be accompanied by an official Fire report from the investigating authority.
- ❖ **ELECTRICAL SURGE:** Pays for damage to the device due to an electrical surge.
- ❖ **NATURAL DISASTERS:** Pays for loss or damage caused by natural disasters.

Exclusions

- ❖ **DISHONEST, FRAUDULENT, INTENTIONAL, NEGLIGENT (NOT LOCKED/STORED IN AN UNSECURED MANNER, OR LOCATION) OR CRIMINAL ACTS:** Will not pay if damage or loss occurs in conjunction with a dishonest, fraudulent, intentional, negligent or criminal act. The student/parents will be responsible for the full amount of the repair/replacement.
- ❖ **CONSUMABLES:** USB charging cable(s), AC adapter, and software.
- ❖ Cosmetic damage that does not affect the functionality of the device. This includes but is not limited to scratches, dents, and broken plastic ports or port covers.
- ❖ “Jailbreaking” or otherwise voiding the manufacturer’s warranty by altering the device.
- ❖ Nebo School District is not liable for any loss, damage (including incidental, consequential or punitive damages) for expense caused directly or indirectly by the equipment.

ISSUANCE AND ACKNOWLEDGEMENT / TERMS AND CONDITIONS

CHROMEBOOK ISSUANCE

I acknowledge receipt of a Nebo School District Chromebook and agree to the following terms and conditions:

1. To be personally responsible for the care and safekeeping of the school district owned Chromebook, and to return the Chromebook immediately to my school on or before the return date specified above or earlier upon request.
2. If the Chromebook is not returned, or is lost or damaged beyond repair, to pay the fair market value of the Chromebook as indicated above. (Coverage for damage or loss to the Chromebook may be acquired through Nebo School District Chromebook Protection Plan or other third-party insurance).
3. To maintain the Chromebook in good condition, normal wear and tear excluded, and to pay for the repair of any damage to the Chromebook caused, directly or indirectly, by the student, the parent(s)/guardian(s), or any other person through neglect. All repairs must be handled by the school district's Technical Services Department. (Coverage for damage or loss to the Chromebook may be acquired through Nebo School District Chromebook Protection Plan or other third-party insurance).
4. To allow the Chromebook to be inspected by the school at any time.
5. To not allow any other person other than the authorized student to use the Chromebook without specific permission of the school.
6. To properly use and care for the Chromebook to the best of our ability.
7. To inform the school immediately in the event of loss or damage to the Chromebook.
8. Negligence by the student in the care of the Chromebook will result in the loss of privilege to use accorded by this Agreement.
9. This Agreement may be cancelled at any time by any party for any or no reason. Upon cancellation, the Chromebook shall be promptly returned to the school.
